(b) A caveat contemplated in this subsection, whether it was entered before or after the commencement of the Insolvency Amendment Act, 1993, shall expire ten years after the date of the sequestration order in question, or six months after the commencement of the said Act, whichever date is the later. The Bipartisan Budget Act of 2018 (Public Law 115's 123) modified the caps on defense and nondefense funding for fiscal year 2018 that were established by the Budget Control Act of 2011 (P.L. 112's 25). The 2018 legislation reset those limits to total \$1,208 billion's \$629 billion for defense programs and \$579 billion for nondefense programs.
